Mr. President,¹

As this is my first time taking the floor, I would like to extend my congratulations to you and to the Philippines on assuming the Presidency of the Thirteenth Meeting of States Parties to the Convention on Cluster Munitions (CCM). You can count on the full support of the United Nations Inter-Agency Coordination Group on Mine Action (IACG-MA)², on behalf of which I am delivering this statement. I congratulate Lao PDR on assuming the presidency of the Third Review Conference

Excellencies,

The proliferation of armed conflicts has led to an exponential increase in explosive ordnance contamination. The UN works with National Authorities and NGOs in countries where cluster munitions, often deployed indiscriminately and covering wide areas, continue to maim, kill, and pose long-term threats to civilians, particularly in densely populated areas. Explosives

that fail to detonate immediately remain hidden in homes, fields, and public spaces—lurking hazards that kill and injure innocent civilians, with children often disproportionately affected. Danger from explosive remnants of war persists long after fighting has ceased, seriously inhibiting the rebuilding of lives and economies.

Amidst heightened geopolitical tensions and widespread conflict, the Secretary-General urges the international community to reaffirm its commitment to humanitarian disarmament with his global campaign, launched on 16 June, to uphold all humanitarian disarmament norms, to accelerate mine action as an enabler of human rights and sustainable development, and to drive forward the vision of a world free of explosive ordnance. Full adherence, implementation and universalization of the Convention on Cluster Munitions must remain a global priority.

In the meantime, while armed conflict and its fallout threaten increased numbers of people around the world, robust mine action programming—integrated across humanitarian, early recovery and development efforts with meaningful engagement of affected people and local actors—is the only viable path to counter the scourge of explosive hazards. Such programming requires predictable, adequate, and flexible funding, and the sustained, resourced and politically engaged support of national mine action authorities, ministries and counterparts.

I urge all Member States to reinforce these efforts through national, multilateral, and innovative actions, ensuring that both emerging crises and long-standing contexts receive support.

Finally, I wish to pay tribute to our colleagues who have made the ultimate sacrifice in the pursuit of a safer world. The deaths and injuries of United Nations, national, NGO and commercial mine action colleagues serve as a solemn reminder of the perilous conditions under which mine action is carried out. Their dedication underscores the life-saving nature of this work and its
